Conditions of approval for exhibition must be met by completing the following:

Membership in good standing (*New members must include completed membership form with payment*)

1. Completed exhibition application, signed and dated
2. Completed waiver, signed and dated

ART EXHIBITION Stipulations:

- The artist(s) must be a current arts council member in good standing (*up to date*)
- The artist(s) may exhibit:
 - a maximum of 4 pieces of their work
 - biography or artist statement and business cards if applicable.
- Artwork must be professionally presented and “gallery ready”: framed, hanging wire, in good condition
- All sales made are subject to a commission of 25%, with a cap of \$50 per piece. If you are a Gallery volunteer and commit to a minimum of 8 hours per month – a commission of only 10% will be charged on sales with a cap of \$20.

SOLO ART EXHIBITION Requirements:

- The artist(s) must arrange to advertise and promote their own show
 - Provide posters and invites etc.
 - The arts council will assist in the promotion through membership e-blast, website announcement, FaceBook post, and posters.
- The artist(s) must coordinate with an arts council representative to arrange hanging of their own work
- The artist(s) must provide professionally presented labels for each art piece
- The artist(s) must organize an opening reception (*Optional but strongly recommended*)
 - Book reception date well in advanced (*One (1) month in advance recommended*)
 - Arrange set-up and clean up
 - Provide refreshments
- All sales must be coordinated between the artist and the arts council
- All sales made in the duration of the exhibition are subject to a commission of 25%, with a cap of \$50 per piece.

WAIVER

The Fort Erie Arts Council will NOT be held responsible for damage or theft of the artwork while on exhibition at The Hub

1. The Fort Erie Arts Council reserves the right to use your photographs of the artwork on exhibition for promotion and media related advertising.
2. This waiver acts as bound contract between the artist(s) and the arts council, and must be signed to be valid.
